Information We Collect

Personal Data We may collect the following personal information:

- Contact information (name, email, phone number, address)

- Demographic data (age, gender, preferences)
- Communication preferences

Technical and Usage Data Automatically collected data includes:

- IP address and device identifiers
- Browser type, operating system, and language
- Access times, clickstream data, page visits, time spent
- Location data
- URLs and referral information
- Cookies and tracking technologies

Use of Personal Data We use personal data to:

- Provide and manage our services
- Improve website performance and user experience
- Communicate with you about services, updates, and promotions
- Ensure compliance with legal obligations
- Detect and prevent fraudulent or harmful activity

- Analyze service usage and effectiveness of campaigns
- Customize content and recommendations

Sharing of Personal Data We may share your personal data:

- With affiliates or subsidiaries under our control
- With trusted service providers and business partners
- During business transfers (e.g., mergers, acquisitions)
- With other users if you share information publicly
- As required by law, regulatory bodies, or court orders
- With your consent

Retention of Data

We retain personal data only as long as necessary to fulfill the purposes for which it was collected, or as required by law. Usage data may be retained for internal analysis, service improvement, and legal compliance.

Data Transfers

Your information may be transferred to, stored, or processed in countries outside of your own. Satwic Inc. will ensure that such transfers are safeguarded in accordance with applicable data protection laws.
